Q1 :

Assign oxidation numbers to the underlined elements in each of the following species:

(a)  $\text{NaH}_2\underline{\text{P}}\text{O}_4$  (b)  $\text{NaH}\underline{\text{S}}\text{O}_4$  (c)  $\text{H}_4\underline{\text{P}}_2\text{O}_7$  (d)  $\text{K}_2\underline{\text{Mn}}\text{O}_4$

(e)  $\text{Ca}\underline{\text{O}}_2$  (f)  $\text{Na}\underline{\text{B}}\text{H}_4$  (g)  $\text{H}_2\underline{\text{S}}_2\text{O}_7$  (h)  $\text{KAl}(\underline{\text{S}}\text{O}_4)_2 \cdot 12 \text{H}_2\text{O}$

Answer :

(a)  $\text{NaH}_2\underline{\text{P}}\text{O}_4$

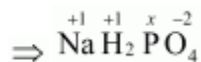
Let the oxidation number of P be x.

We know that,

Oxidation number of Na = +1

Oxidation number of H = +1

Oxidation number of O = -2



Then, we have

$$\begin{aligned} 1(+1) + 2(+1) + 1(x) + 4(-2) &= 0 \\ \Rightarrow 1 + 2 + x - 8 &= 0 \\ \Rightarrow x &= +5 \end{aligned}$$

Hence, the oxidation number of P is +5.

(b)  $\text{NaH}\underline{\text{S}}\text{O}_4$

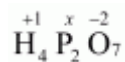


Then, we have

$$\begin{aligned} 1(+1) + 1(+1) + 1(x) + 4(-2) &= 0 \\ \Rightarrow 1 + 1 + x - 8 &= 0 \\ \Rightarrow x &= +6 \end{aligned}$$

Hence, the oxidation number of S is +6.

(c)  $\text{H}_4\underline{\text{P}}_2\text{O}_7$



Then, we have

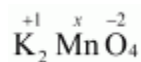
$$4(+1) + 2(x) + 7(-2) = 0$$

$$\Rightarrow 4 + 2x - 14 = 0$$

$$\Rightarrow 2x = +10$$

$$\Rightarrow x = +5$$

Hence, the oxidation number of P is + 5.



Then, we have

$$2(+1) + x + 4(-2) = 0$$

$$\Rightarrow 2 + x - 8 = 0$$

$$\Rightarrow x = +6$$

Hence, the oxidation number of Mn is + 6.



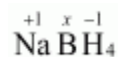
Then, we have

$$(+2) + 2(x) = 0$$

$$\Rightarrow 2 + 2x = 0$$

$$\Rightarrow x = -1$$

Hence, the oxidation number of O is  $\hat{=}$  - 1.



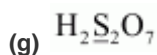
Then, we have

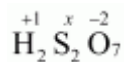
$$1(+1) + 1(x) + 4(-1) = 0$$

$$\Rightarrow 1 + x - 4 = 0$$

$$\Rightarrow x = +3$$

Hence, the oxidation number of B is + 3.





Then, we have

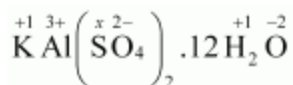
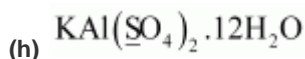
$$2(+1) + 2(x) + 7(-2) = 0$$

$$\Rightarrow 2 + 2x - 14 = 0$$

$$\Rightarrow 2x = 12$$

$$\Rightarrow x = +6$$

Hence, the oxidation number of S is + 6.



Then, we have

$$1(+1) + 1(+3) + 2(x) + 8(-2) + 24(+1) + 12(-2) = 0$$

$$\Rightarrow 1 + 3 + 2x - 16 + 24 - 24 = 0$$

$$\Rightarrow 2x = 12$$

$$\Rightarrow x = +6$$

Or,

We can ignore the water molecule as it is a neutral molecule. Then, the sum of the oxidation numbers of all atoms of the water molecule may be taken as zero. Therefore, after ignoring the water molecule, we have

$$1(+1) + 1(+3) + 2(x) + 8(-2) = 0$$

$$\Rightarrow 1 + 3 + 2x - 16 = 0$$

$$\Rightarrow 2x = 12$$

$$\Rightarrow x = +6$$

Hence, the oxidation number of S is + 6.

**Q2 :**

**What are the oxidation numbers of the underlined elements in each of the following and how do you rationalise your results?**

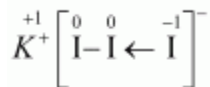
(a)  $\text{K}\underline{\text{I}}_3$  (b)  $\text{H}_2\underline{\text{S}}_4\text{O}_6$  (c)  $\underline{\text{Fe}}_3\text{O}_4$  (d)  $\underline{\text{C}}\text{H}_3\underline{\text{C}}\text{H}_2\text{OH}$  (e)  $\underline{\text{C}}\text{H}_3\underline{\text{C}}\text{OOH}$

**Answer :**

(a)  $\text{K}\underline{\text{I}}_3$

In  $KI_3$ , the oxidation number (O.N.) of K is +1. Hence, the average oxidation number of I is  $-\frac{1}{3}$ . However, O.N. cannot be fractional. Therefore, we will have to consider the structure of  $KI_3$  to find the oxidation states.

In a  $KI_3$  molecule, an atom of iodine forms a coordinate covalent bond with an iodine molecule.



Hence, in a  $KI_3$  molecule, the O.N. of the two I atoms forming the  $I_2$  molecule is 0, whereas the O.N. of the I atom forming the coordinate bond is  $-1$ .

(b)  $H_2S_4O_6$



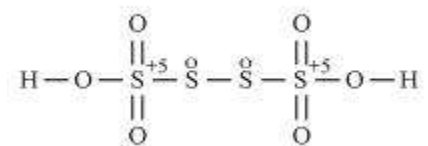
$$\text{Now, } 2(+1) + 4(x) + 6(-2) = 0$$

$$\Rightarrow 2 + 4x - 12 = 0$$

$$\Rightarrow 4x = 10$$

$$\Rightarrow x = +2\frac{1}{2}$$

However, O.N. cannot be fractional. Hence, S must be present in different oxidation states in the molecule.

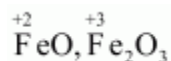


The O.N. of two of the four S atoms is +5 and the O.N. of the other two S atoms is 0.

(c)  $Fe_3O_4$

On taking the O.N. of O as  $-2$ , the O.N. of Fe is found to be  $+2\frac{2}{3}$ . However, O.N. cannot be fractional.

Here, one of the three Fe atoms exhibits the O.N. of +2 and the other two Fe atoms exhibit the O.N. of +3.



(d)  $CH_3CH_2OH$

$$2(x) + 6(+1) + 1(-2) = 0$$

$$\text{or, } 2x + 4 = 0$$

$$\text{or, } x = -2$$

Hence, the O.N. of C is  $-2$ .

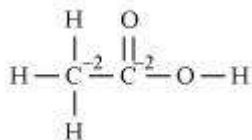
(e)  $CH_3COOH$

$$2(x) + 4(+1) + 2(-2) = 0$$

$$\text{or, } 2x = 0$$

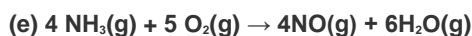
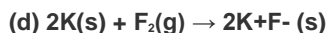
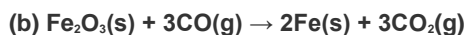
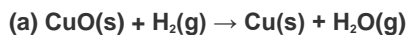
$$\text{or, } x = 0$$

However, 0 is average O.N. of C. The two carbon atoms present in this molecule are present in different environments. Hence, they cannot have the same oxidation number. Thus, C exhibits the oxidation states of +2 and -2 in  $\text{CH}_3\text{COOH}$ .

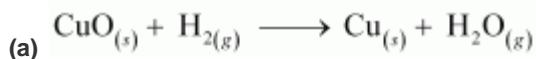

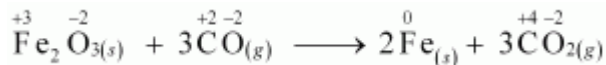
Let us write the oxidation number of each element involved in the given reaction as:



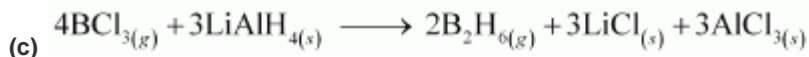
Here, the oxidation number of Cu decreases from +2 in  $\text{CuO}$  to 0 in  $\text{Cu}$  i.e.,  $\text{CuO}$  is reduced to  $\text{Cu}$ . Also, the oxidation number of H increases from 0 in  $\text{H}_2$  to +1 in  $\text{H}_2\text{O}$  i.e.,  $\text{H}_2$  is oxidized to  $\text{H}_2\text{O}$ . Hence, this reaction is a redox reaction.



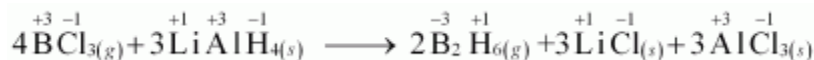
Let us write the oxidation number of each element in the given reaction as:



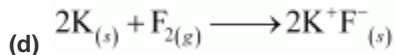
Here, the oxidation number of Fe decreases from +3 in  $\text{Fe}_2\text{O}_3$  to 0 in  $\text{Fe}$  i.e.,  $\text{Fe}_2\text{O}_3$  is reduced to  $\text{Fe}$ . On the other hand, the oxidation number of C increases from +2 in  $\text{CO}$  to +4 in  $\text{CO}_2$  i.e.,  $\text{CO}$  is oxidized to  $\text{CO}_2$ . Hence, the given reaction is a redox reaction.



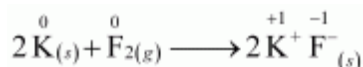
The oxidation number of each element in the given reaction can be represented as:



In this reaction, the oxidation number of B decreases from +3 in  $\text{BCl}_3$  to  $-3$  in  $\text{B}_2\text{H}_6$ . i.e.,  $\text{BCl}_3$  is reduced to  $\text{B}_2\text{H}_6$ . Also, the oxidation number of H increases from  $-1$  in  $\text{LiAlH}_4$  to  $+1$  in  $\text{B}_2\text{H}_6$  i.e.,  $\text{LiAlH}_4$  is oxidized to  $\text{B}_2\text{H}_6$ . Hence, the given reaction is a redox reaction.

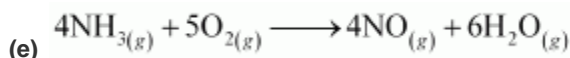


The oxidation number of each element in the given reaction can be represented as:

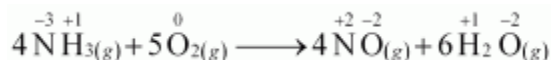


In this reaction, the oxidation number of K increases from 0 in K to +1 in KF i.e., K is oxidized to KF. On the other hand, the oxidation number of F decreases from 0 in  $\text{F}_2$  to  $-1$  in KF i.e.,  $\text{F}_2$  is reduced to KF.

Hence, the above reaction is a redox reaction.



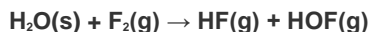
The oxidation number of each element in the given reaction can be represented as:



Here, the oxidation number of N increases from  $-3$  in  $\text{NH}_3$  to +2 in NO. On the other hand, the oxidation number of  $\text{O}_2$  decreases from 0 in  $\text{O}_2$  to  $-2$  in NO and  $\text{H}_2\text{O}$  i.e.,  $\text{O}_2$  is reduced. Hence, the given reaction is a redox reaction.

**Q4 :**

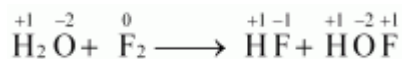
**Fluorine reacts with ice and results in the change:**



**Justify that this reaction is a redox reaction.**

**Answer :**

Let us write the oxidation number of each atom involved in the given reaction above its symbol as:

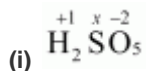


Here, we have observed that the oxidation number of F increases from 0 in  $\text{F}_2$  to +1 in HOF. Also, the oxidation number decreases from 0 in  $\text{F}_2$  to  $-1$  in HF. Thus, in the above reaction, F is both oxidized and reduced. Hence, the given reaction is a redox reaction.

**Q5 :**

**Calculate the oxidation number of sulphur, chromium and nitrogen in  $\text{H}_2\text{SO}_5$ ,  $\text{Cr}_2\text{O}_7^{2-}$  and  $\text{NO}_3^-$ . Suggest structure of these compounds. Count for the fallacy.**

Answer :



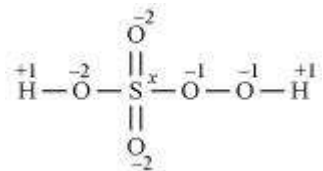
$$2(+1) + 1(x) + 5(-2) = 0$$

$$\Rightarrow 2 + x - 10 = 0$$

$$\Rightarrow x = +8$$

However, the O.N. of S cannot be +8. S has six valence electrons. Therefore, the O.N. of S cannot be more than +6.

The structure of  $\text{H}_2\text{SO}_5$  is shown as follows:

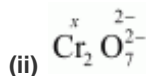


$$\text{Now, } 2(+1) + 1(x) + 3(-2) + 2(-1) = 0$$

$$\Rightarrow 2 + x - 6 - 2 = 0$$

$$\Rightarrow x = +6$$

Therefore, the O.N. of S is +6.



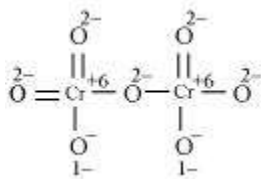
$$2(x) + 7(-2) = -2$$

$$\Rightarrow 2x - 14 = -2$$

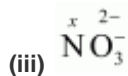
$$\Rightarrow x = +6$$

Here, there is no fallacy about the O.N. of Cr in  $\overset{2-}{\text{Cr}}_2 \overset{2-}{\text{O}}_7$ .

The structure of  $\overset{2-}{\text{Cr}}_2 \overset{2-}{\text{O}}_7$  is shown as follows:



Here, each of the two Cr atoms exhibits the O.N. of +6.



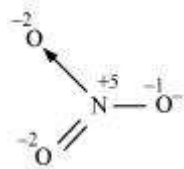
$$1(x) + 3(-2) = -1$$

$$\Rightarrow x - 6 = -1$$

$$\Rightarrow x = +5$$

Here, there is no fallacy about the O.N. of N in  $\text{NO}_3^-$ .

The structure of  $\text{NO}_3^-$  is shown as follows:



The N atom exhibits the O.N. of +5.

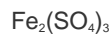

**Q7 :**

**Suggest a list of the substances where carbon can exhibit oxidation states from -4 to +4 and nitrogen from -3 to +5.**

**Answer :**



The substances where carbon can exhibit oxidation states from  $-4$  to  $+4$  are listed in the following table.

Substance	O.N. of carbon
$\text{CH}_2\text{Cl}_2$	0
$\text{ClC}\ddot{\text{C}}\text{Cl}$	+1
$\text{HC}\ddot{\text{C}}\text{H}$	$-1$
$\text{CHCl}_3, \text{CO}$	+2
$\text{CH}_3\text{Cl}$	$-2$
$\text{Cl}_3\text{C}-\text{CCl}_3$	+3
$\text{H}_3\text{C}-\text{CH}_3$	$-3$

Q8 :

While sulphur dioxide and hydrogen peroxide can act as oxidising as well as reducing agents in their reactions, ozone and nitric acid act only as oxidants. Why?

Answer :

In sulphur dioxide (SO<sub>2</sub>), the oxidation number (O.N.) of S is +4 and the range of the O.N. that S can have is from +6 to -2.

Therefore, SO<sub>2</sub> can act as an oxidising as well as a reducing agent.

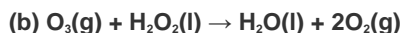
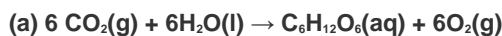
In hydrogen peroxide (H<sub>2</sub>O<sub>2</sub>), the O.N. of O is -1 and the range of the O.N. that O can have is from 0 to -2. O can sometimes also attain the oxidation numbers +1 and +2. Hence, H<sub>2</sub>O<sub>2</sub> can act as an oxidising as well as a reducing agent.

In ozone (O<sub>3</sub>), the O.N. of O is zero and the range of the O.N. that O can have is from 0 to -2. Therefore, the O.N. of O can only decrease in this case. Hence, O<sub>3</sub> acts only as an oxidant.

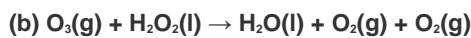
In nitric acid (HNO<sub>3</sub>), the O.N. of N is +5 and the range of the O.N. that N can have is from +5 to -3. Therefore, the O.N. of N can only decrease in this case. Hence, HNO<sub>3</sub> acts only as an oxidant.

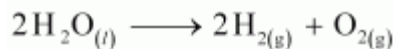
**Also suggest a technique to investigate the path of the above (a) and (b) redox reactions.**

**Answer :**

(a) The process of photosynthesis involves two steps.

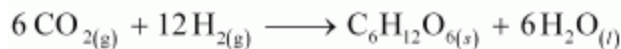
**Step 1:**

H<sub>2</sub>O decomposes to give H<sub>2</sub> and O<sub>2</sub>.

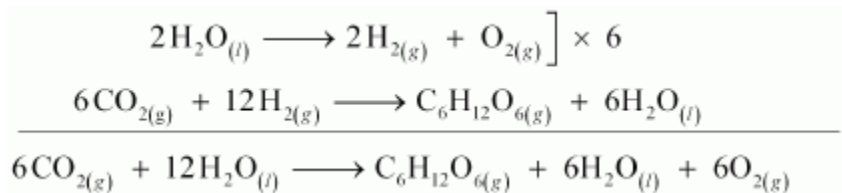


**Step 2:**

The H<sub>2</sub> produced in **step 1** reduces CO<sub>2</sub>, thereby producing glucose (C<sub>6</sub>H<sub>12</sub>O<sub>6</sub>) and H<sub>2</sub>O.



Now, the net reaction of the process is given as:

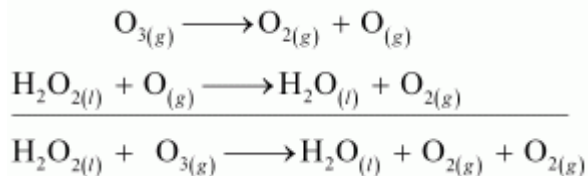


It is more appropriate to write the reaction as given above because water molecules are also produced in the process of photosynthesis.

The path of this reaction can be investigated by using radioactive  $\text{H}_2\text{O}^{18}$  in place of  $\text{H}_2\text{O}$ .

(b)  $\text{O}_2$  is produced from each of the two reactants  $\text{O}_3$  and  $\text{H}_2\text{O}_2$ . For this reason,  $\text{O}_2$  is written twice.

The given reaction involves two steps. First,  $\text{O}_3$  decomposes to form  $\text{O}_2$  and  $\text{O}$ . In the second step,  $\text{H}_2\text{O}_2$  reacts with the  $\text{O}$  produced in the first step, thereby producing  $\text{H}_2\text{O}$  and  $\text{O}_2$ .



The path of this reaction can be investigated by using  $\text{H}_2\text{O}_2^{18}$  or  $\text{O}_3^{18}$ .

**Q10 :**

**The compound  $\text{AgF}_2$  is an unstable compound. However, if formed, the compound acts as a very strong oxidizing agent. Why?**

**Answer :**

The oxidation state of Ag in  $\text{AgF}_2$  is +2. But, +2 is an unstable oxidation state of Ag. Therefore, whenever  $\text{AgF}_2$  is formed, silver readily accepts an electron to form  $\text{Ag}^+$ . This helps to bring the oxidation state of Ag down from +2 to a more stable state of +1. As a result,  $\text{AgF}_2$  acts as a very strong oxidizing agent.

**Q11 :**

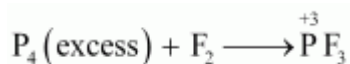
**Whenever a reaction between an oxidising agent and a reducing agent is carried out, a compound of lower oxidation state is formed if the reducing agent is in excess and a compound of higher oxidation state is formed if the oxidising agent is in excess. Justify this statement giving three illustrations.**

**Answer :**

Whenever a reaction between an oxidising agent and a reducing agent is carried out, a compound of lower oxidation state is formed if the reducing agent is in excess and a compound of higher oxidation state is formed if the oxidising agent is in excess. This can be illustrated as follows:

(i)  $\text{P}_4$  and  $\text{F}_2$  are reducing and oxidising agents respectively.

If an excess of  $\text{P}_4$  is treated with  $\text{F}_2$ , then  $\text{PF}_3$  will be produced, wherein the oxidation number (O.N.) of P is +3.

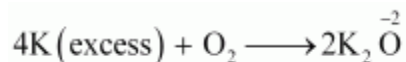


However, if  $\text{P}_4$  is treated with an excess of  $\text{F}_2$ , then  $\text{PF}_5$  will be produced, wherein the O.N. of P is +5.

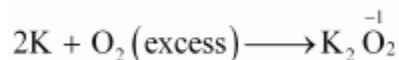


(ii) K acts as a reducing agent, whereas O<sub>2</sub> is an oxidising agent.

If an excess of K reacts with O<sub>2</sub>, then K<sub>2</sub>O will be formed, wherein the O.N. of O is -2.

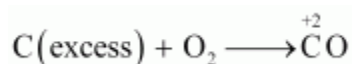


However, if K reacts with an excess of O<sub>2</sub>, then K<sub>2</sub>O<sub>2</sub> will be formed, wherein the O.N. of O is -1.

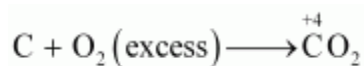


(iii) C is a reducing agent, while O<sub>2</sub> acts as an oxidising agent.

If an excess of C is burnt in the presence of insufficient amount of O<sub>2</sub>, then CO will be produced, wherein the O.N. of C is +2.



On the other hand, if C is burnt in an excess of O<sub>2</sub>, then CO<sub>2</sub> will be produced, wherein the O.N. of C is +4.



Q12 :

How do you count for the following observations?

(a) Though alkaline potassium permanganate and acidic potassium permanganate both are used as oxidants, yet in the manufacture of benzoic acid from toluene we use alcoholic potassium permanganate as an oxidant. Why? Write a balanced redox equation for the reaction.

(b) When concentrated sulphuric acid is added to an inorganic mixture containing chloride, we get colourless pungent smelling gas HCl, but if the mixture contains bromide then we get red vapour of bromine. Why?

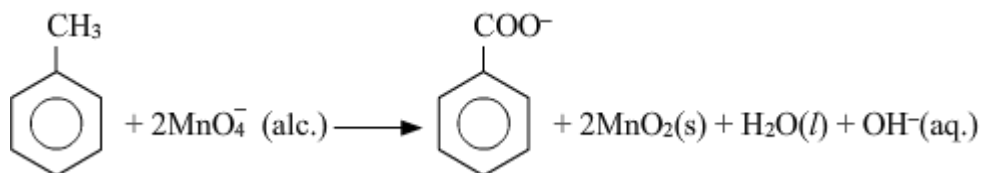
Answer :

(a) In the manufacture of benzoic acid from toluene, alcoholic potassium permanganate is used as an oxidant because of the following reasons.

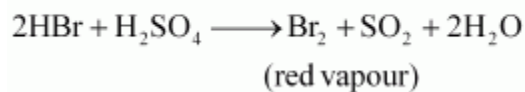
(i) In a neutral medium, OH<sup>-</sup> ions are produced in the reaction itself. As a result, the cost of adding an acid or a base can be reduced.

(ii) KMnO<sub>4</sub> and alcohol are homogeneous to each other since both are polar. Toluene and alcohol are also homogeneous to each other because both are organic compounds. Reactions can proceed at a faster rate in a homogeneous medium than in a heterogeneous medium. Hence, in alcohol, KMnO<sub>4</sub> and toluene can react at a faster rate.

The balanced redox equation for the reaction in a neutral medium is given as below:



(b) When conc.  $\text{H}_2\text{SO}_4$  is added to an inorganic mixture containing bromide, initially HBr is produced. HBr, being a strong reducing agent reduces  $\text{H}_2\text{SO}_4$  to  $\text{SO}_2$  with the evolution of red vapour of bromine.

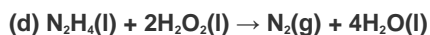
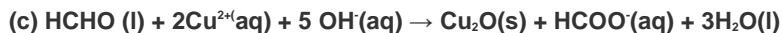
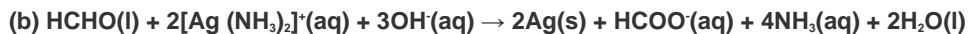


But, when conc.  $\text{H}_2\text{SO}_4$  is added to an inorganic mixture containing chloride, a pungent smelling gas (HCl) is evolved. HCl, being a weak reducing agent, cannot reduce  $\text{H}_2\text{SO}_4$  to  $\text{SO}_2$ .

Identify the substance oxidised, reduced, oxidising agent and reducing agent for each of the following reactions:



Answer :

(a) Oxidised substance  $\hat{=}$   $\text{C}_6\text{H}_6\text{O}_2$

Reduced substance  $\hat{=}$   $\text{AgBr}$

Oxidising agent  $\hat{=}$   $\text{AgBr}$

Reducing agent  $\hat{=}$   $\text{C}_6\text{H}_6\text{O}_2$

(b) Oxidised substance  $\hat{=}$   $\text{HCHO}$

Q14 :

Consider the reactions:



Why does the same reductant, thiosulphate react differently with iodine and bromine?

Answer :

The average oxidation number (O.N.) of S in  $\text{S}_2\text{O}_3^{2-}$  is +2. Being a stronger oxidising agent than  $\text{I}_2$ ,

$\text{Br}_2$  oxidises  $\text{S}_2\text{O}_3^{2-}$  to  $\text{SO}_4^{2-}$ , in which the O.N. of S is +6. However,  $\text{I}_2$  is a weak oxidising agent. Therefore, it

oxidises  $\text{S}_2\text{O}_3^{2-}$  to  $\text{S}_4\text{O}_6^{2-}$ , in which the average O.N. of S is only +2.5. As a result,  $\text{S}_2\text{O}_3^{2-}$  reacts differently with iodine and bromine.

Q15 :

Justify giving reactions that among halogens, fluorine is the best oxidant and among hydrohalic compounds, hydroiodic acid is the best reductant.

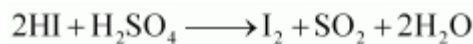
Answer :

$\text{F}_2$  can oxidize  $\text{Cl}^{\ominus}$  to  $\text{Cl}_2$ ,  $\text{Br}^{\ominus}$  to  $\text{Br}_2$  and  $\text{I}^{\ominus}$  to  $\text{I}_2$  as:



On the other hand,  $\text{Cl}_2$ ,  $\text{Br}_2$ , and  $\text{I}_2$  cannot oxidize  $\text{F}^{\text{ae}}$  to  $\text{F}_2$ . The oxidizing power of halogens increases in the order of  $\text{I}_2 < \text{Br}_2 < \text{Cl}_2 < \text{F}_2$ . Hence, fluorine is the best oxidant among halogens.

$\text{HI}$  and  $\text{HBr}$  can reduce  $\text{H}_2\text{SO}_4$  to  $\text{SO}_2$ , but  $\text{HCl}$  and  $\text{HF}$  cannot. Therefore,  $\text{HI}$  and  $\text{HBr}$  are stronger reductants than  $\text{HCl}$  and  $\text{HF}$ .



Again,  $\text{I}^{\text{ae}}$  can reduce  $\text{Cu}^{2+}$  to  $\text{Cu}^+$ , but  $\text{Br}^{\text{ae}}$  cannot.



Hence, hydroiodic acid is the best reductant among hydrohalic compounds.

Thus, the reducing power of hydrohalic acids increases in the order of  $\text{HF} < \text{HCl} < \text{HBr} < \text{HI}$ .

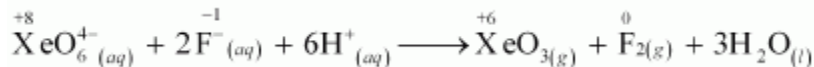
**Why does the following reaction occur?**



**What conclusion about the compound  $\text{Na}_4\text{XeO}_6$  (of which  $\text{XeO}_6^{4-}$  is a part) can be drawn from the reaction.**

**Answer :**

The given reaction occurs because  $\text{XeO}_6^{4-}$  oxidises  $\text{F}^-$  and  $\text{F}^-$  reduces  $\text{XeO}_6^{4-}$ .

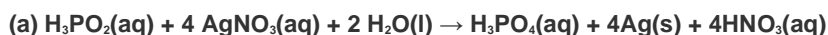


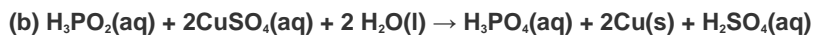

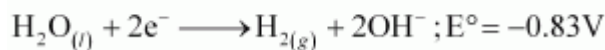
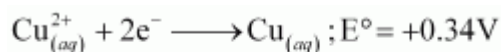
Hence, at the cathode,  $\text{H}^{+}$  ions are reduced to liberate  $\text{H}_2$  gas.

On the other hand, at the anode, either of  $\text{SO}_4^{2-}$  ions or  $\text{H}_2\text{O}$  molecules can get oxidized. But the oxidation of  $\text{SO}_4^{2-}$  involves breaking of more bonds than that of  $\text{H}_2\text{O}$  molecules. Hence,  $\text{SO}_4^{2-}$  ions have a lower oxidation potential than  $\text{H}_2\text{O}$ . Thus,  $\text{H}_2\text{O}$  is oxidized at the anode to liberate  $\text{O}_2$  molecules.

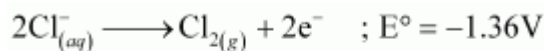


On electrolysis, either of  $\text{Cu}^{2+}$  ions or  $\text{H}_2\text{O}$  molecules can get reduced at the cathode. But the reduction potential of  $\text{Cu}^{2+}$  is more than that of  $\text{H}_2\text{O}$  molecules.



Hence,  $\text{Cu}^{2+}$  ions are reduced at the cathode and get deposited.

Similarly, at the anode, either of  $\text{Cl}^{\text{aq}}$  or  $\text{H}_2\text{O}$  is oxidized. The oxidation potential of  $\text{H}_2\text{O}$  is higher than that of  $\text{Cl}^{\text{aq}}$ .



But oxidation of  $\text{H}_2\text{O}$  molecules occurs at a lower electrode potential than that of  $\text{Cl}^{\text{aq}}$  ions because of over-voltage (extra voltage required to liberate gas). As a result,  $\text{Cl}^{\text{aq}}$  ions are oxidized at the anode to liberate  $\text{Cl}_2$  gas.

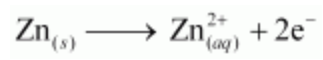
